LSL Ordinance

They stated the Village of Frederic is doing a great job and have been diligent in inspecting and identifying water line material. They went through the need for an ordinance in regards to the replacement of lead service lines in the Village. The Board did not have any questions.

Mobile Food Vehicle Vendor Ordinance – Governance Recommendation.

Currently the ordinance states 150 feet, there was some concern that that was not far enough for all restaurants, after discussion it was decided that the ordinance should be changed to 200 feet, unless the brick-and-mortar restaurant did not have concerns about the location of the MFV.
